Message from the Executive Director



I am pleased to present the 2010 Annual Report for NAFOPHANU.

2010 was again an eventful year with greater advocacy creating a lot of impact on the national level. During the course of the year, the Forum streamlined its Governance Structure by electing a new Board of Directors. The two year term plan for the Board was developed to particularly ensure effective program implementation, as well as strengthening the Forum in to a formidable force for high quality service delivery and improving the resource base through lobbying and mobilization.

On the internal structure, following the completion of the Strategic Plan, a lot of changes occurred at the Secretariat, most importantly, the Forum now has a new Executive Director, after the out going Executive Director submitted his resignation to pursue other career opportunities. The new positions of Finance and Administration Manager have since come into existence. This is envisaged to enhance the capacity of the Human Resources Department to steer the Organization to greater heights.

At district level, we have managed to support 40 districts in the day to day running of the district forums. The has helped the districts to network better and more efficiently. Six National networks were also supported.

At national level, NAFOPHANU has been part of the **NO ARVs NO VOTES** Campaign to have health services as a priority issue during the 2010/2011 political campaigns. CAAT meetings have also provided a platform for advocates to lobby for better treatment services.

We were also privileged to contribute to National HIV response including taking the lead in organizing of the national World AIDS Day and Philly Lutaaya Day in Kampala and Nakasongola respectively. 80 districts were also supported to host Philly Lutaaya Day and World AIDS Day 2010 respectively.

In addition to the above, the media was engaged for mass sensitization on the HIV basics. This has been done using four regional radio stations, and UBC Television.

Let me take this opportunity to thank everyone at the Secretariat and every member of the institution for the enormous energy, commitment, dedication and team work displayed in 2010.

I also thank our Development Partners: the Civil Society Fund, Partnership Fund of UAC, Great Lakes Initiative on AIDS (GLIA), EANNASO, NUMAT, STAR-EC and UNAIDS, for the resourceful support, both financial and technical, that has kept the Forum thriving and we pray that we keep up the spirit as we continue to respond to HIV&AIDS.

NAFOPHANU has had challenges too. However comparatively, and with support we seek to make NAFOPHANU a center of Advocacy, Empowerment and the Influence of Persons Living With HIV, increasingly being recognized locally, regional and internationally.

About NAFOPHANU

The National Forum of People Living with HIV/AIDS Networks in Uganda (NAFOPHANU) was established in May 2003 and registered with the National NGO Board in May 2004 with a country wide mandate as an umbrella organization for Persons Living with HIV/AIDS (PLHIV) to provide systematic and all inclusive coordination structure for PLHIV networks, associations and support groups in order to play advocacy, policy and decision making roles in the HIV/AIDS partnership. This was after identification, acknowledgement and recognition of gaps among PLHIV initiatives in the National Response. This was reached through a process that involved numerous consultative meetings of PLHIV from PLHIV initiatives in Uganda, with support from UNAIDS and the HIV/AIDS Partnership Committee of the Uganda AIDS Commission.

This annual report highlights the commitment and concerted mandate NAFOPHANU holds towards the HIV National Response.





Critical interventions in the National HIV Response

The report elaborates on the Work Plan activities, Interventions, Donor Support, Sub Grant Mechanisms and Collaborations that occurred in the year 2010. Additionally, the report indicates the challenges, best practices, lessons learnt, and recommendations encountered. The report covers all donor support including; PC, CSF, STAR EC, NUMAT, Heps-Uganda, and Great Lakes Initiative on AIDS, among others.

Civil Society Fund

a) Capacity Building and Technical Support

A guiding principle of the Forum is to build local and regional capacity so that national programs can achieve results, monitor and evaluate their activities, and sustain our programs. CSF funded on-spot trainings and these were conducted for district coordinators and staff of national networks in Financial Management, writing books of accounts, monitoring and evaluation.

b) Supporting Multi-Sectoral HIV Coordination Mechanisms

Since the overall mandate of NAFOPHANU is to coordinate networks of Persons Living with HIV, this has been done both at the district and national level through district forums at district level and through national networks at national level.

By facilitating members of the district executive of PLHIV to meet on a monthly basis, PLHIV have had an opportunity to discuss issues affecting them within their districts and come up with possible recommendations. In these meetings, various Partners from the district local government and members of CSOs are invited to participate.

This has given them chance to discuss coordination issues within their districts. In the end, many lower level networks have been formed within the districts and hence easy mobilization of PLHIV constituency.

In a number of Districts, the following departments attended the district coordination meetings;

- District HIV&AIDS Focal Person
- District Community Development Officer
- District Health Officer
- Partners in the district

c) Institutional Governancei) Board Meetings

There were periodic/quarterly Board Meetings to guide management. The last one took place in November 2010. A new Board was elected and inducted.

ii) Annual General Meeting

Towards the close of the year, an Annual General meeting was held on the 17th September 2010 at Green Valley Hotel in Ggaba. The assembly of PLHIV retained

their Chairperson, Dr. Stephen Watiti and made a few changes within the members of the BoD.

iii) Staff Restructuring

A number of staff were laid off due to drastically reduced funding from our current donors. The staff that was retained had their job descriptions reviewed to take on other roles, and also basing on the implementation of the Forum SP. The Executive Director, Mr. Kibanga, Samuel James, resigned from his position to pursue other career options. The Program Manager, Stella Kentutsi, has since been promoted to the position of Executive Director effective January 2011.

d) Information Management

Information Management at national level through Internet support conduits such as website and mailing list is managed by the I.E.C Office at the Resource Center. In many districts, the information is still stored manually except in a few districts like Gulu, Kampala, and Lira where there is availability of computers to store such information.

Disaggregation of information is done based on the design of the report, newsletters formats i.e. by sex, region, Sub County, and so on. This information is used in the planning process and for reporting obligations. This information was used for the following:

- Re-focusing the ongoing projects
- Meeting the Reporting obligation to stakeholders
- Planning and designing future projects

e) Advocacy Interventions

i) Radio programs

Following the success of radio talk shows on local FM stations in 2007/2008, bimonthly radio talk shows were continued on local FM stations to cover major regions. These included Kaboozi Kubiri for the Central region, Radio West for Western and South-Western regions, Open Gate (OPG) FM for Eastern and North-Eastern regions and Mega FM for Northern region. These were hosted by the district PLHA Forums and other partners. The radio programmes advocated for the needs and rights of PLHIV at all levels using local languages.

ii) TV talk shows

Monthly TV talk shows and documentaries continued to be broad-cast as NAFOPHANU furthered her Advocacy role of disseminating information regarding PLHIV and HIV&AIDS generally. For continuity and due to wider national coverage, Uganda Broadcasting Corporation (UBC) Television was used. The TV programs were coordinated by NAFOPHANU but run jointly with The Uganda Network on Law, Ethics and HIV/AIDS (UGANET), Uganda Network of AIDS Services Organizations (UNASO) and other Partners.

iii) Monthly Consortium of Advocates for Access to Treatment (CAAT) meetings

NAFOPHANU has hosted the Consortium of Advocates for Access to Treatment (CAAT) since 2007. CAAT stands for evidence based advocacy and lobbying and over 30 HIV related organizations come together every month to discuss issues related to availability and consistence of drug supply especially ARVs, change of regimen without prior notice to PLHIV, bouncing at health centers with drug stock outs or missing files, client monopoly among other issues. The district forums and PLHIV networks as well as district focal point persons are selected from various regions to represent others and report on the status of treatment. This is done on a rotational basis. This has

and continues to help to get information from across the country that is used to lobby policy makers and other relevant stakeholders for reliable and consistent access to treatment.

iv) Dialogue Meetings

Held harmonization meetings with ART providers, NMS, MoH in the country, this was as a result of concerns which were coming up from People Living with HIV&AIDS in different corners of the country as regards to the status of treatment which include stockouts of ARVs, closure of ART centers, not enrolling PLHIV in ART Center among others.

Partnership Fund

i) World AIDS DAY

The Forum with support from Uganda AIDS Commission-PC, was honored to organize the national commemoration of World AIDS Day.

The ceremony was commemorated at Kitebi Primary School in Kampala. Hon. Loyce Biira Bwambale was the Guest of Honor at this World AIDS day commemoration. She thanked participants including; Representatives from Development Partners, Uganda AIDS Commission, Ministry of Health, The Head teacher, Kitebi Primary School, Kampala City Council, the entire community.

Hon Biira also appreciated the national theme; "I HAVE A DUTY TO PROTECT EVERY CHILD FROM HIV AND AIDS...DO YOU?" that Ugandan AIDS partners had adopted and said that it's in line fighting for the rights of children and will work to commit government and all other concerned partners towards HIV and AIDS national

response.

Other guests included representatives from, National Council for Children, UAC, MoH, UNAIDS, ICW, Members of Parliament, Kampala District PHA forum Representative, and the Special Guest Ruth Awori, a child living with HIV, among others.

ii) Philly Lutaaya Day

He also in a special way appreciated those who have come up openly to disclose their HIV sero-status. He thanked UAC and NAFOPHANU.

In his speech, he said as a church, they are much involved in advocacy especially to children in regards to abstinence .

He asked all people to stay pure and holy and that all HIV and AIDS organizations should as well include religious issues in their HIV interventions. He further called upon people to stop discrimination and stigma as well as blaming each other for positive results after getting tested. He urged to all people to use the talking tool to sensitize and educate every one and provide them with accurate and concise information about HIV and AIDS.

iii) Advocacy Guidelines

Under PF, the Forum developed and disseminated Community Advocacy Guidelines which are targeted to enable Advocates/Activists to utilise information and services available to reduce transmission of HIV, and also reduce the impact of HIV on individuals, communities and organisations. It is a guide developed from the Advocacy Strategy to lobby multiple partners

iv) Coordination Meetings

The Forum held Youth and Women coordination meetings where the representatives to the Board of Governors were chosen from each cluster.

Other Advocacy activities done

NMS

Visited National Medical Stores in February 2010 in to verify the availability of ARVS in Uganda. This was after complaints of drug stock outs in the country yet Global Fund had released money to procure drugs for people living with HIV&AIDS. It was revealed that drugs were procured and stocked in the store but they were not reaching people who needed them as a result of a complex supply chain.

Forum Launches

Formed and launched new sub county PLHIV Forums in Wakiso District. The sub counties included Nangabo, Busukuma, Gombe and Namayumba Town Council and the executive committees were elected so as to strengthen the networks to have evidence based information starting from grass root level.

Advocacy Team

An Advocacy Team was formed to strengthen the Advocacy of the Forum and to also have a strong united voice of PLHIV at national level. The Team includes PLHIV representatives on various committees of Ministry of Health (HPAC), PC, CCM who forward PLHIV issues after discussion for further interventions.

HIV Bill

The Forum was part of the consortium of CSOs cordinated by UGANET to sensitize PLHIV on the HIV Prevention and Control Bill for the populace to be well informed

about that Bill and how it infringes on the rights of People Living with HIV&AIDS in some clauses like criminalization of HIV Transmission, HIV Disclosure and Mandatory Testing among others.

HEPS-Uganda

Participated in a Campaign to end Pediatric HIV&AIDS which was officially launched in Uganda in 2010 by The Coalition for Health Promotion and Social Development, HEPS-U.

Participated in A Medicine Transparency and Monitoring Survey in Kisoro district under Medicine Transparency Alliance to monitor the availability and delivery of medicines in the districts down to final consumer and a report was done. The Forum is also a member of Stop Stockout Campaign.

Platform 2011

NAFOPHANU was part of the The 2011 Election Campaign to Stop AIDS Through Treatment and Prevention, which was a Coalition of Networks of People Living with HIV, Civil Society Organizations, Religious Leaders, and health workers calling on all candidates for Presidential and Parliamentary elections, and all political parties, to commit to achieving national HIV Treatment and Prevention Goals that will ensure Uganda's AIDS response is not merely good, but great. The Campaign was spear headed by ICW/EA. This will be concluded after the General elections of 2011.

Collaborations and Partnerships

1. UNAIDS

UNAIDS supported the Forum to complete and review the Strategic Plan. Dr. Sekiwanuka James a consultant was hired to execute this task. The SP forged a way forward for the PLHIV constituency for 3 years.

2. University of KwaZulu Natal

The institute of Professional and Legal Studies in the

University of KwaZulu Natal, with support from Open Society Institute and UNDP sponsored individuals from Uganda, Malawi, Zambia, Zimbabwe, South Africa for a course in South Africa.

The 2 week course focused on intellectual property and access to medicines without hindrances from manufacturers especially regarding Generics including ARVs. Stella Kentutsi represented the Forum in South Africa in July 2010.

3. Networks of African People Living With HIV-East Africa NAP+ EAR

The Network thats brings together 11 countries at the close of 2010 held a delegates conference in Arusha, Tanzania. The Forum was delighted to be represented by 6 delegates, five of whom were board members. The conference's critical agenda was to recognize their leadership to further boost the network advocacy work.

Flavia Kyomukama was elected as the new Board Chairperson for NAP+ EAR.

4. ACORD Uganda

Apart from housing our Gulu District PLHIV office, ACORD conducted training for PLHIV executive members from Mbarara, Isingiro, Ibanda and Kiruhura. Covered topics like Procurement, Internal Control, Financial Management, Communication Skills, Monitoring & Evaluation among others. This took place in February 2010.

5. NUMAT

Northern Uganda Malaria AIDS Tuberculosis Programme (NUMAT)'s goal is to expand access to and utilization of HIV, TB and malaria prevention, treatment, care and support activities in Northern Uganda. NAFOPHANU, in partnership with UGANET and with support from NUMAT and as part of ongoing support to PLHIV in their organized groups, conducted trainings in Succession Planning and Will Making. NUMAT and NAFOPHANU coorganized training for TOTs in Succession Planning and will making which lasted for 5 days.

Participants were selected from the sub-counties of the 9 district PHA Forums that make up Lango and Acholi sub-regions and also came from the UPDF divisions of Acholi Pii (Pader) and Fourth Division (Gulu). A total number of 30 participants were trained.

NAFOPHANU and NUMAT conducted a joint M&E exercise that covered 9 districts including selected sub-counties. This was intended to assess capacity gaps, capture advocacy issues and provide on-spot coaching.

6. STAR EC

The 5-year project is based in East Central Uganda. Its main objective is to strengthen responses in the fight against TB and AIDS. It operates in the six districts of Busoga namely Kaliro, Mayuge, Kamuli, Namutumba, Iganga and Bugiri. PLHIV are involved in the project largely as Community Support Agents (CSAs), coordi-

nated by NACWOLA.

As part of ongoing support to people living with HIV (PL-HIV) networks, STAR-EC supported an orientation for PLHIV network leaders on coordination district and sub-



county levels in the districts of Bugiri , Kaliro, Mayuge and Iganga. New structures of PLHIV leadership were put in place.

Mayuge District supported by STAR EC.

STAR EC has been and continues to be involved in the day to day running of Naluwerere Wellness Centre, a facility which was established by GLIA project and funded by World Bank.

7. EANNASO


EANNASO is a network of 15 national networks in 14 countries. It has been in existence since 2002, working in networking, advocacy, information and communication, as well as monitoring and evaluation.

In September 2010, The AIDS Budget Unit (ABU) of the Governance and AIDS Programme (GAP), in partner-ship with The Eastern Africa National Networks of AIDS Service Organisations (EANNASO), convened a five-day capacity-building workshop on HIV & AIDS budget analysis and resource tracking for EANNASO staff and members in East Africa, in Nairobi, Kenya. The training was attended by participants from Burundi, Kenya, Rwanda, South Africa, Tanzania, Uganda and Zanzibar. Florence Nagawa, the Forum Advocacy Officer was one of the participants.

8. GREAT LAKES INITIATIVE ON AIDS

The World Bank funded project, GLIA, is a regional initiative and has been in existence in Uganda since 2006. The project runs four components with categorized implementers.

The mission of GLIA is to contribute to the reduction of HIV infection and to mitigate the social-economic impact of the epidemic in the Great Lakes Region. Among other components, GLIA Component 2 deals with HIV/AIDS support along the northern transport corridor, and implemented by both the Amalgamated Transport and General workers Union (ATGWU) and the National Forum of PHLA Networks in Uganda (NAFOPHANU) with coordination from Uganda Aids Commission.

This component focuses on support to HIV/AIDS related networks with the main activity as establishment and functioning of Wellness Centers (WCs) which also act as Resource Centres. These WCs were established in three pilot districts of the country which include; Mbuya – Kampala, Naluwerere-Bugiri, and Rubaare-Ntungamo.

The main purpose for these Wellness Centres is to provide Information, Education and Counseling, Guidance and Hope to the target population; who are the community, PLHIV, and truck drivers. The centers are also used as communication centres through the Internet.

Other activities carried out included SALT visits, Self Assessments, and trainings.

The funding from World Bank toward the project ended December 31st 2010 and now the networks still with coordination from UAC, are in control and mainly mobilizing resources to ensure the project sustainability.

9. UGANDA CARES

In the bid to enhance health services especially those of HIV, Uganda Cares worked with NAFOPHANU at national and district levels. The collaboration engaged the media through a press conference that brought together District Health Officers, PHAs, HIV service providers, donors. The press briefing emphasized the removal of 'CAPS' that had been indicated by different donors in as far as funding treatment on HIV is concerned.

10. AMFIU

The Association of Microfinance Institutions of Uganda (AMFIU), which is the national umbrella organization of microfinance institutions (MFIs) in Uganda, implemented a one year pilot project on microfinance and HIV&AIDS supported by HIVOS in the Netherlands. AMFIU, is working in partnership with two national organizations namely NAFOPHANU, the umbrella body of all organizations, networks and groups of People living with HIV and AIDS and ACORD (Agency for Cooperation and Research in Development).

The pilot project aimed at enabling MFIs and organi-

zations working with, and for People Living with HIV in Uganda to jointly face the challenges posed by HIV & AIDS and will be the basis for rolling out a 5year project. The ultimate aim of the 5year project is to enhance capacities of microfinance institutions in Uganda to reduce the impact of HIV and AIDS on their clients and the microfinance industry.

11. CCEDU

NAFOPHANU was a member of the Health Cluster under the Citizen's Coalition for Electoral Democracy in Uganda that trained PLHAs as election monitors in Gulu, Arua. I.E.C materials were provided.

12. LOCAL GOVERNMENT

Local Governent helped to house PLHIV District Forum coordination offices in most districts and also engaged PLHIV on District Committees on HIV & AIDS.

Program Monitoring and Evaluation

The following activities were conducted;

- Built the capacity of the national M&E officer in various M&E techniques like Lot Quality Assurance Sampling (LQAS)-STAR E.
- M&E mentoring and coaching of beneficiary networks
- On-spot training to member networks
- Work plan review
- Finance management review meetings.
- End of project evaluation planned for the first quarter of 2011.

2010 Achievements

- Conducted the Annual General Assembly where new Board members were elected.
- Prevention and treatment awareness manual was completed and translation into 4 major languages of Luo, Luganda, Runyankore and Ateso has been.
- Advocacy Strategy was completed and is guiding the Advocacy work at district and national level.
- 40 District Forums and 6 National Networks have

- been financially and technically supported and this has made PLHIV movement more visible in the national response. This is further supported by MIPA and GIPA principle
- The capacity of PLHIV have been built in different areas especially in writing books of accounts and financial management.
- The Management and Administrative systems of 40 district forums have been strengthened. This has greatly improved the method of work and operations.
- The transition at district levels was concluded with the election of new office bearers in 20 districts. This happened not only to improve service delivery for PLHIV constituency but also solve the problem of leadership wrangles that had dogged most districts forums. The changes in Human Resources at the Secretariat has also improved on the efficiency of work at the national level.

Major Technical Gaps

- Some District Forum Coordinators could not correctly write books of accounts and this was addressed by the Accounts Department through onspot training.
- Report writing was also a challenge to some coordinators. With time, they have improved with guidance from the secretariat and partners in the region.
- The reports are not shared with District Local Government leadership and this has had implications on the coordination system at local levels. However, it should be noted that most district HIV&AIDS committees are non functional and yet this is the very critical point were these reports are suppose to be discussed.
- Inadequate skills in proposal writing were also identified which have made districts unable to access funds outside from what is being sent from the National Secretariat. This is also the same when it comes to Government programmes like NAADS, NUSAFII and many others.

Success Stories, Lessons Learnt and Best Practices Success Stories

- Income Generating Activities for PLHIV in Mityana
- PLHIV Networks are more visible in districts across the country
- Continuous and consistent extension of Financial and Technical support to district forums across the country.
- Enforcement of GIPA and MIPA principle in the national response.
- Continuous and consistent flow of information among stake holders informs implementation and operations

- Timely accountability to the project beneficiaries and other stakeholders like donors improves confidence to management.
- Microfinance Institutions will work with PLHIV networks

Lessons Learnt

- Livelihood support to PLHIV is very crucial amidst high level of poverty even beyond the PLHIV fraternity.
- District AIDS coordination structures such as Task force/Committee (DAT/DAC) and Sub-county AIDS Taskforce/Committee (SAT/SAC) are non functional or meet irregularly and this has a direct bearing on the functionality of PLHIV networks within the district.

Constraints/Challenges

- Low technical capacity among the leaders and staff of district forums across the country. This has not only resulted into poor accountability, but also to delay in effectively using the money released to them
- Ever increasing cases of drugs stock out across the country which is putting the lives of most PLHIV at jeopardy.
- The increased number of districts across the country is stretching the abilities of the National Forum in terms of coverage. Even then, district forums have been sub-divided which calls for launch of the new networks to fit into the coordination structure.
- Accountabilities and reports from a number of districts are not delivered in time
- The area of coverage and needs of networks are too big compared to the resource base.
- Delays in release of funds from donors
- Inadequate skills among PHA networks in handling project funds
- Dormant network accounts
- Inadequate staffing at the secretariat for effective implementation of activities.
- Limited feedback/communication system to and from the secretariat
- The advocacy issues are too many and usually un budgeted for.
- Funding from the donors has reduced for most projects and thus limited resources for HIV/AIDS players in the country.

Way Forward

- Consolidating the available resource base and exploring new funding opportunities
- PLHIV National Conference scheduled for 2011 to foster the PLHIV Advocacy Agenda
- Revitalizing the Advocacy Agenda for the PLHIV movement in Uganda
